Brince Manning Papers DeKalb Parks and Recreation Part of the Robert W. Espy IV Collection

Scope and content: The documents were found in the basement of the Pythagoras lodge in downtown Decatur and were given to the history center by Robert Espy to become part of his family collection. The name that appears most on this particular collection is Brince Manning, who served as Chairman of DeKalb county's Board of Commissioners in the 1960s. They appear to be papers from his time in the position and cover 1942 to 1968.

Description: The files were found in the basement of the Pythagoras lodge which had been used for storage by the DeKalb County Parks and Recreation Department. In the effort to clean up the building, some documents were lost, so this collection represents only a part of the original collection. This part of the Espy collection seems to be the professional papers of Brince Manning, hence the name. There are materials on street lights, sanitation, the Ku Klux Klan, urban renewal, phone, police and water services and fluoridation of the water supply. The bulk of the material is from the 1960s.
