Organizational history of DeKalb County's Department Family and Children's Services:

The vision of the Department includes the following statement: "To be an agency committed to protecting vulnerable children and adults and improving the social and economic well-being of families by providing excellent service in a professional manner and by being accountable to DeKalb County residents."

The DeKalb County Department of Family and Children Services began as the DeKalb County Department of Public Welfare in 1937. It was to administer funds from the Social Security Act of 1935 to needy members of the community. As DeKalb County grows, so does the demand for the Department's services and many changes in responsibility have occurred. The Department handles temporary assistance for needy families, food stamps, child care and parent services, including reports of child abuse, as well as refugee assistance and Medicaid programs.

Description: The information is primarily filed by date in chronological order, but near the end of the collection, original order was preserved and chronological order is broken somewhat. The materials in the collection are mostly annual reports, and sometimes the materials used to put them together, board minutes and two folders of clients' letters, which have been typed, preserving spelling and grammar errors. There are also several photographs of the Lynwood Nursery School from May 1955.
