HUDGINS - HUDGENS - Mr. E. Ragan Pruitt, 1308 Renee Dr., Lilburn, GA 30247 wants the name of the wife and 13 children of Revolutionary soldier WILLIAM HUDGINS or HUDGENS, b, ca. 1762. He filed for a pension in 1832 in Upson Co., GA, when he was 70. He had served in the Revolution from NC. He mentioned in the application that he had 13 children. When he finally received the pension he was 98 years old!

EDITOR'S NOTE: The final return of William's pension will likely show the names of his surviving children. It will be microfilmed as part of the "complete" pension film series. The Federal Records Center at East Point, GA probably has that pension microfilm, so you could read it there.

Was Mrs. ELIZABETH THACKER, seen in the 1790 census of Pendleton Dist., SC, his mother? There was a young male in her household who could have been William.

Were RANSOM and NATHAN THACKER, seen nearby in the census also her sons? These families moved away from SC by 1800.

Ransom and William are known brothers, and were found in the area which became New Madrid Co., MO as early as 1801. William d. there in 1811, but by 1808 Ransom moved to the area which became East Feliciana Parish, LA. In 1811 when
