

Sanford P. Haynie  
and  
Sarah C. Haynie

Sanford P. Haynie is buried in the Peachtree Baptist Church cemetery. He was born October 19, 1837, and died May 25, 1895. His wife was Sarah C. Haynie.

1880. Sanford P. Haynie appears on the 1880 census of DeKalb County, Georgia, living in the 531st (Decatur) Georgia Militia District. He appears on the census in the 47th enumeration district, sheet 6 as follows:

Sanford P. Haynie, white, male, age 42, married, farmer, born in South Carolina as were his parents.

Sarah C. Haynie, his wife, white, female, age 45, married, keeping house, born in South Carolina as were her parents.

Mary J. Haynie, his daughter, white, female, age 15, no occupation, born in South Carolina.

Sarah E. C. Haynie, his daughter, white, female, age 9, born in Georgia.

Ora A. Haynie, his daughter, white, female, age 7, born in Georgia.

Alfred C. Haynie, his son, white, male, age 4, born in Georgia.

1895. Sanford P. Haynie applied for a Confederate soldier's pension as a resident of Bartow County, Georgia, in 1895. In his application he states the following:

Born in Anderson, South Carolina, October 19, 1837.

~~Enlisted in Confederate army at Anderson, South Carolina, in May 1862 in Company E, 20th Regiment South Carolina Volunteer Infantry. Served until discharged near Charlotte, North Carolina, in 1865 at end of war.~~

Co. E 20th S.C.

He has been unable to work except for some farming and gardening.

He has hurting of the spine, kidney problems, diarrhea, and general debility (supported by a doctor's statement).

He lived in Fulton County in 1893 and 1894.

He is supported by his son.

He has a wife, four daughters, and two sons.

He is living with his daughter.

He has no property.

The witness to his application, E. P. Brooks, says

~~He served in the same Confederate unit as Sanford P. Haynie. Haynie has lived with him for four years. (Does this mean that Brooks was his son-in-law, since Haynie says he is living with his daughter?)~~

1897. Mrs. S. C. Haynie filed a Confederate widow's pension application in Bartow County in 1897 as the widow of Sanford P. Haynie. She says he died May 25, 1895 and that she is in a destitute condition. (No further application for Mrs. Haynie is present, indicating that she either died or moved out of State by the next year.)

Further searches to be made:

1. Look in 1900 and 1910 soundex to census for Sarah C. Haynie. Especially, try to find out who the other two children were. (Pension says he had six; 1880 census only shows four.

2. Look in DeKalb, Fulton, and Bartow counties for marriage records of S. P. Haynie's children: Mary J., Sarah E. C., Ora A., and Alfred C. Haynie.
3. Look in 1880 agricultural census for Sanford P. Haynie, DeKalb county, especially to see if he owned land or was a tenant farmer.
4. Look in DeKalb County deeds index to see if he owned land.
