Thomas Jefferson Flake, (b. 1838, d. 1921), son of William Green Flake and Adeline Maddux, was an Atlanta area resident. He married Laura Hulsey, daughter of Eli Jennings Hulsey. He was born and lived his early life in Russell County, Alabama.

In (October of 1861, he enlisted in Company A, Waddell's Battalion Artillery, Alabama Volunteers. In the Civil War, he fought in the Siege of Vicksburg, Miss., and was captured on July 4, 1863 when the Confederate forces surrendered. The War was officially over for him when he was surrendered in April of 1865 in Columbus, Ga.


Thomas Flake's profession was suveying. Following the Civil War, he, and his brother Eugene, lived in Atlanta. There he met, and married, Laura Hulsey. Through this marriage he acquired a great deal of land in DeKalb County, in the area of Wesley Chapel. The land had originally been owned by Merrell Collier, Eli Hulsey's father-in-law and pioneer settler of Atlanta. There Thomas Flake farmed and operated a water powered mill. He continued to survey in the county and is credited with the lay out of many of DeKalb County's early roads. Flake's Mill Road still exists in southern DeKalb County. He also built a small school on his land to educate his children and those of neighboring farms, it was known as South River Academy. Thomas Jefferson Flake died in 1921 in DeKalb County at the age of 83.
