his address as of Jan. 1, 1906 Chamblee, Ga.

DeKalb County, Ga." an
incomplete roster of nine companies
and a list of veterans living in the
county in 1906 as shown by the tax
digest of DeKalb County.

You may more information on these soldiers if you wish, by visiting or writing to
the Confederate Records Section at the Ga. Archives Bldg. (just off the I20 exit
at Capitol Ave., Atlanta) For a small fee they will copy whatever information
they have as for service records and any pension records on these soldiers. Just
give the name and company, regiment of these soldiers.

There will be a thumbnail sketch about these military companies in one of the six
volumes of Lillian Hendeson's "Roster of Confederate Soldiers of Georgia" which
may be found at many libraries including the one here in Decatur, the Maud Burrus
Library, in the reference section. The volumes have the companies listed by
county, company, and regiment and the names alphabetically. These rosters include
only infantry soldiers and other sources of Confererate history should not be
overlooked. However, I believe both of your men listed above are in these books.

Other genealogical file cards we have on Hudgins show Jeffrey William Hudgins
and William Hudgins, private, drafted, with notation "State Archives".
