DeKalb Deeds Part of the Robert W. Espy IV Collection

Scope and content: The land deeds were found in the basement of the Pythagoras lodge in downtown Decatur and were given to the history center by Bob Espy to become part of his family collection. The earliest deeds are from the 1920s and there are also those from the 1950s, but the bulk of the collection is from 1930s and 1940s.

Size: 13 document boxes and one of miscellaneous documents.

Description: The files were found in the basement of the Pythagoras lodge which had been used for storage by the DeKalb County Parks and Recreation Department, also a part of the Espy collection. We do not know how the land deeds came to be there or from where they originate, but they contain names and land lot numbers for property in DeKalb County. The deeds are on old and acidic copy paper that is crumbling, so care must be taken when handling the documents.
