Scottdale Mills Collection

Scope and content: The Scottdale Mills collection contains statements of accounts, cash books, checks, payroll lists, stock certificates, itemized account journals, W-2 forms and other items from Georgia Duck and Cordage, the Estate of J.J. Scott, Scottdale Mills, Fenner Dunlop and Whittier Mills. The collection begins in 1899 and contains records through 2008. Access is restricted as the books are kept in cooler basement storage for safety. Please call ahead.

Size: Over 100 Volumes of Financial and Personnel Records, 1 oversized document box, 4 document boxes, map and plans, ephemera.

Brief Organizational Sketch of Scottdale Mills: Scottdale Mills was opened in 1901 by George Washington Scott and closed in 1982. The mill was a business that also built homes for workers on surrounding land. The Scottdale Mills Village homes were rented for 25 cents per room per week, but rent would be excused in hard times, according to an interview with Milton Candler Scott. A school building for workers was eventually taken over by the county and a nurse and dental clinic were also onsite. The Scott family also owned the Georgia Duck and Cordage Mill. The Scottdale location was last owned by Fenner Dunlop Americas, Inc., based in Pittsburgh, Pennsylvania, incidentally the birthplace of Milton Candler Scott. At its peak, the mill employed 600 workers and spun and wove an average of 25,000 bales of cotton annually. A high point of 750 workers occurred during the Vietnam War in the 1960s, driven by demand for cloth for uniforms and sandbags. In 1971, Scottdale Mills closed down Whittier Mills Company near Chattahoochee Brick Company, as it was never very successful. The mill in Scottdale was torn down in 2010-2011 and will be redeveloped.

Description: The majority of the Scottdale Mills Collection consists of books of financial information such as assets and liabilities, W-2 tax forms, payroll, payment registers, retirement benefits, invoices, payment reports, itemized account journals and board minutes. There are 112 ledger books and file boxes. There is also tax information and the paperwork from renewing the charter in 1949. The collection includes lists of prices that individuals paid for Scottdale cemetery plots, Scottdale Mills ephemera and proposed warehouse plans.
