### H.H. Burgess and Ben F. Burgess Papers

**Scope and content:** The H.H. Burgess and Ben F. Burgess papers contain documents that cover 1880 until 1920. There are original receipts, small desk diaries and Civil War veteran ribbons. Both men were clerks for DeKalb Superior Court, so there are documents from the courts as well, such as tax receipts, cancelled checks payable to the court and executor documents.

**Biographical Sketch of Burgess Family members:** Henry Harrison Burgess was born in 1939 and married Elizabeth Wright. Burgess was clerk of DeKalb Superior court, and his son B.F. Burgess was also clerk. A note from the DeKalb New Era says that Ben B. Burgess, perhaps another son of Henry, also served as clerk.

**Description:** The Burgess Collection contains diaries, receipts, Superior Court records and some original Civil War veteran items, including the pension document for A.C. Burgess. There are original receipts from local businesses and diaries of notes. There are estate records for George W. Wright; H.H. Burgess was executor of his estate. There are also receipts for Decatur Academy and Donald Fraser high school for W.H. Wright, for whom H.H. Burgess was guardian.
