

Fourth National Bank Gives Decatur Metropolitan Facilities

The Decatur Branch of the Fourth National Bank of Atlanta furnishes Decatur with metropolitan banking facilities and in addition thereto retains to the city community

The Decatur Branch of the Fourth is the old DeKalb County Bank, now become a part of this great National Banking House. The DeKalb County Bank was organized in 1911 by the late J. O. Norris and operated successfully until 1922 when it became a part of the Fourth. At the time of the merger it was under the direction of Frank T. Hopkins, President and C. H. Blount, Cashier.

The Fourth National of Atlanta is 37 years of age. It has a history of faithful service and steady growth. Today its resources are more than 40 millions of dollars. The

Decatur branch is housed in a new modern building erected in 1924.

While Decatur has every modern metropolitan facility through this branch of the great Atlanta bank, the community conveniences have been retained, such as longer hours and an advisory board, appointed from local stockholders. The Decatur Branch is under the management of C. H. Blount. Mr. Blount came to Decatur in 1914 as Cashier of the DeKalb County Bank and has remained with this institution since that date except for a short period during the war when he was in Army.

The Advisory Board is composed of the following prominent citizens of DeKalb County: George E. Everitt, Andrew Sledd, Frank O. Watkins, James A. Hall, L. E. Morehead, L. J. Cassells, Scott Candler, J. Frank Kelley, I. L. Rogers and Frank T. Hopkins.

This building will be a substantial structure, and will prove a great addition to the appearance of the business section of the city.

The plane for this building have been made, and it is expected that the satual work of construction will be started early in the new year.

The building is expected to be finished during this coming stumer.
