1856. The will of James Paden, paternal grandfather of Emily Wilson Paden Tuggle is recorded in DeKalb County Will Book A, page 263-265. It lists his wife Lettice, his daughter Elizabeth (wife of W.B. Chandler), his son Thomas N. Paden, his daughter Lettice Caroline (wife of James Strange), his son James, his daughter Jane, his son John, and his niece Mary Ann Hassel. In his will he disposes of land and several slaves. His son Thomas N. Paden is co-executor of the will. The will was dated November 29, 1859, and was probated December 27, 1864.

1860. John Tyler Tuggle is shown as living with his parents on the 1860 census of Hall County, Georgia, in the 392nd Georgia Militia District, Chesnut Mountain Post Office, on page 185, dwelling 1383, family 1177, as follows:

C. M. Tuggle, age 32, male, farmer, real estate: \$500, personal property: \$300, born in Georgia.

Sally Tuggle, age 40 (1), female, born in Georgia.

S. E. (L. E.?) Tuggle, age 10, female, born in Georgia.

Dillah Tuggle, age 8, female, born in Georgia.

John Tuggle, age 6, male, born in Georgia.

Lewis Tuggle, age 4, male, born in Georgia.

Nancy Tuggle, age 6 months, female, born in Georgia.

M. A. Brown, age 16, female, born in Georgia.

1860. Emma Wilson Paden, wife of John T. Tuggle, appears on the 1860 census as a resident with her family in the Decatur militia district of DeKalb County, Georgia, page 295, dwelling 272, family 272, as follows:

Thomas N. Paden, age 40, farmer, real estate: \$2,200, personal property: \$350, born in South Carolina.

Nancy Paden, age 39, domestic, born in South Carolina.

James R. Paden, age 20, farmer, born in Georgia.

Andrew W. Paden, age 19, farmer, born in Georgia.

Mary C. Paden, age 16, born in Georgia

Jane S. Paden, age 13, born in Georgia

John T. Paden, age 6, born in Georgia

Emry (sic) W. Paden, age 4, born in Georgia.

1861. Thomas N. Paden, the father of Emily Wilson Paden Tuggle, was commissioned a first lieutenant in the militia company of the 531st Georgia Militia District of DeKalb County on December 28, 1861. (See Register of Commissions Issued, 1841-1862, page 229).

~~1863. Thomas N. Paden, the father of Emily Wilson Paden Tuggle, enlisted as a private in a local defense organization called the "DeKalb Cavalry" on August 4, 1863. This company became Company A, 10th Regiment, Cavalry, Georgia State Guards, commanded by Captain Milton A. Candler. The regiment was called into the service of the Confederate States for local defence to serve that portion of Georgia north of a line commencing at a point in the Chattahoochee River where the line between the counties of Muscogee and Chattahoochee strike the river, running across the State along the Muscogee railroad to the City of Macon, thence in a direct line to that point on the Savannah River where the line between the counties of Richmond and Burke strike the river." The muster-in roll of the company shows (1) he was enlisted by J. C. Williams, Captain, Georgia Militia; (2) he furnished a horse valued at \$550 and equipment valued at \$25; and (3) he was present. The only other record is the company muster-out roll which shows he was present and was paid \$50.25 as commutation for the use of his horse.~~
