Civil War Collection

Scope and content: The Civil War collection includes letters, muster rolls and other records dating from 1860 to 1872, including wartime correspondence between Missouri Stokes and DeWitt Morgan.

Provenance: Collection is made up of multiple donations found in the subject files in 2010.

Five letters written by DeWitt Morgan to Missouri Stokes during 1861 and 1862 were donated in 1984 by Mrs. Ralph I. Poucher.

The history of the 42nd Infantry Regiment was donated by Joseph T. Butler: accession date December 7th, 1994; accession #1994.32

Biographical Sketch of Missouri Stokes: Missouri Stokes was the half-sister of prominent DeKalb County resident Mary Gay, who used the journal kept by Stokes in writing her book, *Life in Dixie during the War*. Stokes was a teacher in many places around Georgia and is mentioned often in her sister's book, but her connection with DeWitt Morgan is unknown.

Biographical Sketch of DeWitt Morgan: DeWitt Clinton Morgan was born on November 15th, 1837 and served as a Sergeant in Company E of the 7th Georgia Infantry Regiment until he was discharged at Camp Bartow in September of 1861 due to illness. Morgan appears to have rejoined after recovering from his illness and served in Company D of the 42nd Georgia Infantry Regiment in 1862. According to Mary Gay, Morgan was killed during the Siege of Vicksburg in 1863.

Description: This collection includes letters and muster rolls dating from 1860 to 1872 as well as a booklet on the history of the 42nd Infantry Regiment dating from 1900. Many of the letters were written by DeKalb resident DeWitt Morgan to Missouri Stokes in the years prior to his death. The muster rolls found in the collection are for the companies in which Morgan served during the Civil War. Another notable item in the collection is a handwritten copy of a letter from former Union army General William T. Sherman to

S.A. Marshall in 1866. The majority of the letters in the collection have no apparent connection with DeKalb County but they do reference the Civil War on several occasions.

The Morgan and Stokes letters were donated to the DeKalb Historical Society in 1984 by Mrs. Ralph I. Poucher. Morgan was the brother of Mrs. Poucher's grandmother, Margaret Morgan Ramspeck, and found the letters amongst other family memorabilia. It is possible that the other letters were also donated at this time, which may explain the geographic discrepancies.
