

Our recently digitized plat map collection can offer you countless hours of entertainment and the history of a neighborhood or street. A Plat map shows legal property ownership. It may include boundary markers and structures on the property.

Our newly digitized collection has plat maps created between 1912 and 1936 to show prospective buyers the boundaries of new lots. Many of these large parcels were owned by one person and were being subdivided. Some of these subdivisions came to fruition, while others were never created. Even if some of these subdivisions were not created you can still see hints of the proposed development in alleyways and unique street designs. The following are some great

> finds that show the anticipated development of subdivisions around the intersection of Memorial Drive and Candler Road.



In this image you can see a proposed development of land owned by Charles L. Greene in 1927 on Morgan Street (renamed Alston Drive). The lots in the 1927 map are tiny - only 20 x 100 and include an alley and parking spaces out front. My best guess is that these were anticipated to be apartment walkups

What's New in the Archives





October Programs Feature

October means cooler weather, pumpkins, and 735 students visiting the DeKalb History Center for History Quest. Each year, hundreds of students explore our Historic Complex, immersing themselves in history as they meet consequential people from the past. Students heard from Susan B. Anthony in the Swanton House and 18th-century poet Phillis Wheatley Peters in the Thomas Barber cabin. The fireplace was lit in the Biffle Cabin where Fiddlin' Dan the Mountain Man brought Georgia History to life through folk music.

Students also met James Oglethorpe, Paul Revere, a Tuskegee Airman, an Auburn Avenue businessman, and Jim Sawgrass, a native Floridian of Muscogee Creek (Mvskoke) descent and living historian.

For nearly a decade, almost every fourth grader in the Decatur City School System has participated in this enriching program, and nearly half of the students visit from Title 1 schools. We are committed to continuing this invaluable experience for future generations of 4th and 8th graders. Thank you, volunteers, for helping this program run smoothly year after year.

Hops Program: The Winecoff Hotel Fire

Earlier this month we learned about the Winecoff Hotel Fire in downtown Atlanta, one of the deadliest fires in American history, killing 119 hotel occupants. One of the survivors was Dorothy Moen, 16, who was in town for the YMCA's Youth Legislature.

Her daughter, Janet Cox, spoke to the DeKalb History Center about her mother's determination to survive as she jumped from the window of her 4th-floor hotel room. Dorothy spent six months recovering at Grady Hospital becoming one of Grady's first water therapy patients. She later became a master stenographer at Fort Benning.
